Sub- Regarding Disability scholarship on National Scholarship Portal 2.0

Sir,

I am directed to state that Department of Social Welfare, Delhi has been designated as Nodal Department for implementation of Disability scholarships of GoI (Pre-matric scholarship for students with disabilities, Post-matric scholarship for students with disabilities and Scholarship for Top Class Education for students with disabilities) for the state of Delhi. The applications are being accepted on NSP portal 2.0. We are scrutinising and forwarding the application to the Department of Empowerment of Persons with Disabilities (Divyangjan).

We are also responsible for adding of new institutes and providing id and password for District/Institute/schools on the portal. Some institutions are not registered till date so students are facing inconvenience in applying. It was found that the number of application received on-line from our state on the portal is very less so you are requested to kindly instruct the institutions which are not yet registered on the portal to contact the nodal department with following information :

1. DISE/ AISHE code & scanned copy of the Registration Certificate in jpeg format (size should not be more than 200kb)
2. Name, email, mobile number of the person authorised to receive the login id and password

The role of the Institute is as follows-

- 1.1. Verify student applications and scanned documents from the originals.
- 1.2. Responsibility of Institute to not forward any application without verification of student information with scanned documents.
- 1.3. Documents to be checked by the Institutes are:-
  - a) student photo
  - b) scanned copy of parental income certificate (duly signed by Revenue Authority/Tehsildar. Form 16 is not acceptable)
  - c) Scanned copy of Aadhaar card/Aadhaar enrollment id.


- d) Scanned copy of disability certificate issued by competent authority
- e) Scanned copy of bank pass book/cancelled cheque leaf
- f) Scanned copy of previous year mark sheet
