Subject: Financial Assistance to the Students under Economically Weaker Section (EWS) Scheme of the University for the year-2014-15.

The Directorate of Students' Welfare invites applications from the students of the GGS Indraprastha University (University Schools of Studies & affiliated institutes) belonging to the Economically Weaker Section of the Society for grant of financial assistance under the EWS scheme of the University for the year 2014-15.

Important Instruction for submission of application:

1. The eligible students, as per the EWS Scheme of the University for the year 2014-15, may apply for grant of financial assistance **on prescribed format of the application form and submit the same alongwith all requisite documents to the concerned Dean, USS/Director or Principal, affiliated institute.**
2. **The closing date in respect of students for submission of application form to the concerned Dean, USS/Principal, affiliated institute is 15.09.2014.**
3. The Deans, USS/Directors or Principals, affiliated institutes should forward all the applications forms alongwith all requisite documents, recommendation & a list of applicants to the Director, Students' Welfare.
4. **The closing date in respect of USS/ affiliated institutes for submission of forms in the Directorate of Students' Welfare is 25.09.2014 till 03.00 pm.**
5. No application will be received directly from the students/parents or by post. All the applications should be forwarded through proper channel to the Director, Students' Welfare.
6. The guidelines of the EWS Scheme, details of required documents, procedure for submission of application and prescribed format of application form may be downloaded from the University's website, i.e., www.ipu.ac.in under the link of Students' Welfare.
7. All the applicants are advised to access the University's website on regular intervals for latest updates. No separate information shall be sent by post or conveyed telephonically.
8. The Deans, USS/Directors or Principals, affiliated institutes are advised to ensure that all requisite documents have been enclosed alongwith the form and all the information given by the student has been verified from the office records. **Application of ineligible students or incomplete applications must be returned to the students within 03 days from the date of submission of application.**
9. Application of ineligible students or incomplete applications will not be considered for grant of financial assistance.
10. Applications received after the due date will not be accepted and no communication will be entertained.
