

- He briefed us about how we require IP in our academics for management of data.


- He added about how we can develop our skills through IP and use it to add into our growth and knowledge.
- He further briefed about IP and its connection to various sectors like teaching, Research and its related right.




- Mr. Gambhir took over after Mr. Jere to explain various sectors IP helps
- He added that how IP is helps in research and development of student like R&D, universities and PRIs produce results in the form of inventions, scholarly publications, databases, new plant varieties, confidential information, computer programs, etc.
- He told us about online classes have been benefited in pandemic through IP and how further IP will be benefiting the Teaching sector
- He briefed us about IP policies in teaching sector which deals with:
 - ownership of and right to use the IP;
 - procedures for identification, evaluation, protection and management of IP
 - procedures for cooperation with third parties;
 - * guidelines on the sharing of profits from successful exploitation; and
 - ❖ Mechanisms to ensure respect for third-party IP rights.
- He told us about an effective IP policy:
 - provide legal certainty;
 - nurture an environment that supports and encourages innovation and development;
 - encourage researchers to consider the possible opportunities for exploiting an invention so as to increase the potential flow of benefits to society;
 - facilitate the creation of public-private partnerships to support economic development;
 - * encourage mutually beneficial relationships with other institutions;
 - balance the various conflicting interests of the university, industry and society; and
 - ***** Ensure compliance with applicable national laws and regulations.














































Learning outcome
