पुलिस जांच से असंतुष्ट रणजीत सिंह के पिता ने जनवरी 2003 में पंजाब और हरियाणा हाईकोर्ट में याचिका दायर कर अपने बेटे की हत्या को जांच सीबीआई से करवाने की मांग की थी, जिसे हाईकोर्ट ने मंजूर कर लिया। सीबीआई ने इस मामले में राम रहाम समेत पांच लोगों के खिलाफ नैसर्गिक दंड किया था। आठ अक्टूबर 2021 को कोर्ट ने पांचों को करार दे दिया और 18 अक्टूबर को उन्हें आजीवन जेल का सजा सुना दी।
