
Online proposals are invited from **AICTE approved Institutions/Students studying in AICTE approved institutions/Courses** (within AICTE approved course wise intake) for the academic year 2021-22 for disbursement of PG Scholarship through DBT mode to the eligible admitted students in 2021-22.

The last date for the submission of online applications under AICTE PG Scholarship Scheme has been extended up to 31<sup>st</sup> January 2022. The details of online Portal for the scheme and deadlines for the online applications by students and its verification by the respective institutions are as follows:

1	Last date for generation of student id by the institutions and submission of online application by students at AICTE web portal ( <a href="https://pgscholarship.aicte-india.org/">https://pgscholarship.aicte-india.org/</a> )	31 <sup>st</sup> January 2022
2	Last date for the Student Verification by respective institutions including re-submitted defective applications at AICTE web portal ( <a href="https://pgscholarship.aicte-india.org/">https://pgscholarship.aicte-india.org/</a> )	15 <sup>th</sup> February 2022

The guidelines of the above scheme may be accessed at AICTE website. The students who are eligible and are admitted in the AICTE approved institutions and AICTE approved courses, as per scheme guidelines, may submit their application in the portal. The students are advised to submit their online applications well in time so that their institutions are able to verify applications within the prescribed timelines. Applications received after the last date shall not be entertained.

The eligible institutions are also advised to verify applications of their students immediately after receiving the applications on the online portal.
