The Central Vigilance Commission has decided that this year Vigilance Awareness Week would be observed from 26<sup>th</sup> Oct'2021 to 1<sup>st</sup> Nov'2021 with the theme “ **Independent India @ 75: Self Reliance with Integrity**”.

Corruption can be defined as dishonest or unethical conduct by a person entrusted with a position of authority, either to obtain benefit to oneself or to some other person. It is a global phenomenon, affecting all strata of society in some way or the other. Corruption undermines political development, democracy, economic development, the environment, people's health and much more. It is, therefore, imperative that the public be sensitized and motivated towards efforts for weeding out corruption. E-governance, and systemic changes in procedures, minimal discretion, reduced public interface, technology based procurement and automation will go a long way in reducing corruption. The Commission has, therefore, been advising all organizations/departments to identify and implement effective preventive measures to fight corruption and to enhance transparency and accountability in their functioning.

The purpose of Vigilance Awareness Week is to generate awareness in the public at large about the ill effects of corruption.
