- d. Analyse and recommend improvements in components of NCC training, including through introduction of concepts like "Ek Bharat, Shresth Bharat", Border Security, Coastal Security etc.
- e. Suggest measures to nurture NCC cadets as grassroots community leaders, motivators and catalytic agents for socio-economic progress.
- f. Analyse and recommend improvements in training philosophy with a view to align NCC with Armed Forces, including thorough use of their training infrastructure.
- g. Study and recommend international best practices for similar youth organizations for inclusion in NCC's curriculum.
- h. Recommend measures to enhance NCC's reach across the country, with a special emphasis on border areas and under-developed areas.
- i. Review and recommend amendments to the NCC Act, 1948.
- j. Review of any pending recommendation made by any expert committee in the past where relevant.
- k. Any other issue which serve to enhance the stated objective or effectiveness in achieving delivery of outcomes
- l. Any other item/items identified with the permission of the Chairperson.

3. The Committee will interact with relevant stakeholders and visit various NCC establishments as necessary. The DoD shall organise the necessary secretarial assistance to the Committee. It may also make any other administrative arrangements as may be required to ensure smooth functioning of the Committee. Non-official members of the Committee shall be paid TA/DA for attending the meetings of the Committee and undertaking visits to NCC establishments as per Travelling Allowance Rules and Sitting Fee as per Ministry of Finance O.M. No. 19047/10/2016-E-IV dated 12.4.2017.

4. The Committee shall submit its report to the Ministry of Defence within a period of 3 months.
