We are happy to inform you that, the AICTE Approval Process 2022-23 has been started on 29-03-2022 and in the Appendix -6 of APH (page no 135-137) following norms specific to innovation and entrepreneurship are highlighted for all institutions to consider while preparing for approval from AICTE.

### 6.1: Essential Requirements for Technical Institution

**Item no 42: Institution's Innovation Council:** HEIs are required to establish IIC in their campus and make it functional. For approval, the institute is required to submit the IIC registration number and establishment certificate copy, for this, if the institution has not yet established an IIC, then please register at [www.iic.mic.gov.in](http://www.iic.mic.gov.in) and complete the my nomination of president for IIC institute and 'My Council' so that institute will able to get the registration number and down the IIC establishment certificate. Please go through the attachment for more information about IIC. Those have already registered in the IIC portal and received approval but not functional yet, please complete the My Council Section so that IIC Institute will be able to get the various benefits provisioned for IIC institutions.

### 6.2: Desirable Requirements for Technical Institutions

**Item no 1: Implementation of the schemes announced by Govt. of India:** Institutions are requested to take part in various I&E initiatives of the Ministry of Education's Innovation Cell. Visit [www.mic.gov.in](http://www.mic.gov.in) for various programs offered by the MoE's Innovation Cell.

**Item no 9: Efforts to encourage students to participate in National/International Competitions like SIH, NIC etc.:** MoE's Innovation Cell Conduct various national innovation competitions such as Smart India Hackathon (SIH), National Innovation Contest (NIC), Toyathons etc on regular intervals. HEIs are requested to encourage their students to take part in these competitions. Institute can visit [www.mic.gov.in](http://www.mic.gov.in) to know more about such competitions.

**Item no 18: Intellectual Property Cell (IP):** It is expected that, all technical institutions should establish IP cells in their campuses to accept the IP generation and technology transfer activities and the incharge of IP cell should be part of the IIC Institute and join as IP coordinator.

**Item no 20: Implementation of Startup Policy:** It is expected that all technical institutions should adopt innovation and start-up policy by formulating an inclusive and responsive Innovation and Entrepreneurship action plan at the institute level and further implementation of the same by the IIC of the institution. Please make sure that the nominated NISP coordinator should be part of the IIC Institute and join as coordinator. Details about NISP adoption and registration is available at [www.nisp.mic.gov.in](http://www.nisp.mic.gov.in)

**Item no 21: Social Media Cell:** As prescribed, the institute should have a social media cell and social media sites where the achievements and upcoming events should be posted on a regular basis. It is requested that the Social Media Cell incharge should be part of the IIC Institute and join as Social Media coordinator.

**Item no 23: Participation in the National Innovation Ranking (ARIIA):** All technical institutions are requested to take part in the annual innovation ranking exercise - Atal Ranking of Institutions on Innovation Achievements (ARIIA) conducted by MoE's Innovation Cell and AICTE. Currently the registration for ARIIA 2022 is undergoing. If your institute has not yet registered/confirmed participation yet, please visit [www.ariia.gov.in](http://www.ariia.gov.in) and register at the earliest.

### **Institution's Innovation Council (IIC):**

The Ministry of Education (MoE) through MoE's Innovation Cell (MIC) launched the Institution's Innovation Council (IIC) program in collaboration with AICTE for Higher Educational Institutions (HEIs) in 2018 to systematically foster the culture of innovation and start-up ecosystem in Higher education institutions.

So far a network of more than 2900 IIC institutions has been established. Primarily, IICs' role is to engage a large number of faculty, students, and staff in various innovation and entrepreneurship-related activities such as ideation, Problem-solving, Proof of Concept development, Design Thinking, IPR, project handling and management at Pre-incubation/Incubation stage, etc., so that innovation and entrepreneurship ecosystem gets established and stabilized in HEIs.

The IIC model is designed to address the existing challenges/issues in HEIs such as fewer numbers, occasional and unplanned Innovation & Entrepreneurship (I&E) activities with low involvement of top leadership, lack of coherence, and absence of synergy in resource mobilization, deployment, and underutilization of the creative potential of youths as a major barrier for vibrant I&E ecosystem to emerge from HEIs. IIC model is unique and distinct as it integrates the functionalities of flexible calendar activities, scoring and reward system, decentralizing operation with the division of work, progress monitoring, and incentive mechanisms in a coordinated manner through a robust digital platform.

In the last three years, IIC has emerged as a very sustainable and scalable model for promoting innovation within HEIs and the efforts of these IIC Institutes can be seen as an impactful contribution towards making the country's innovation and start-ups ecosystem more vibrant and dynamic. The recent achievement of India's 46th position in the Global Innovation Index (GII) ranking 2021 is a reflection of the same. The soon you will submit, we will evaluate and approve the establishment of IIC accordingly and it will help you to start conducting the IIC activities for the AY 2021-22.

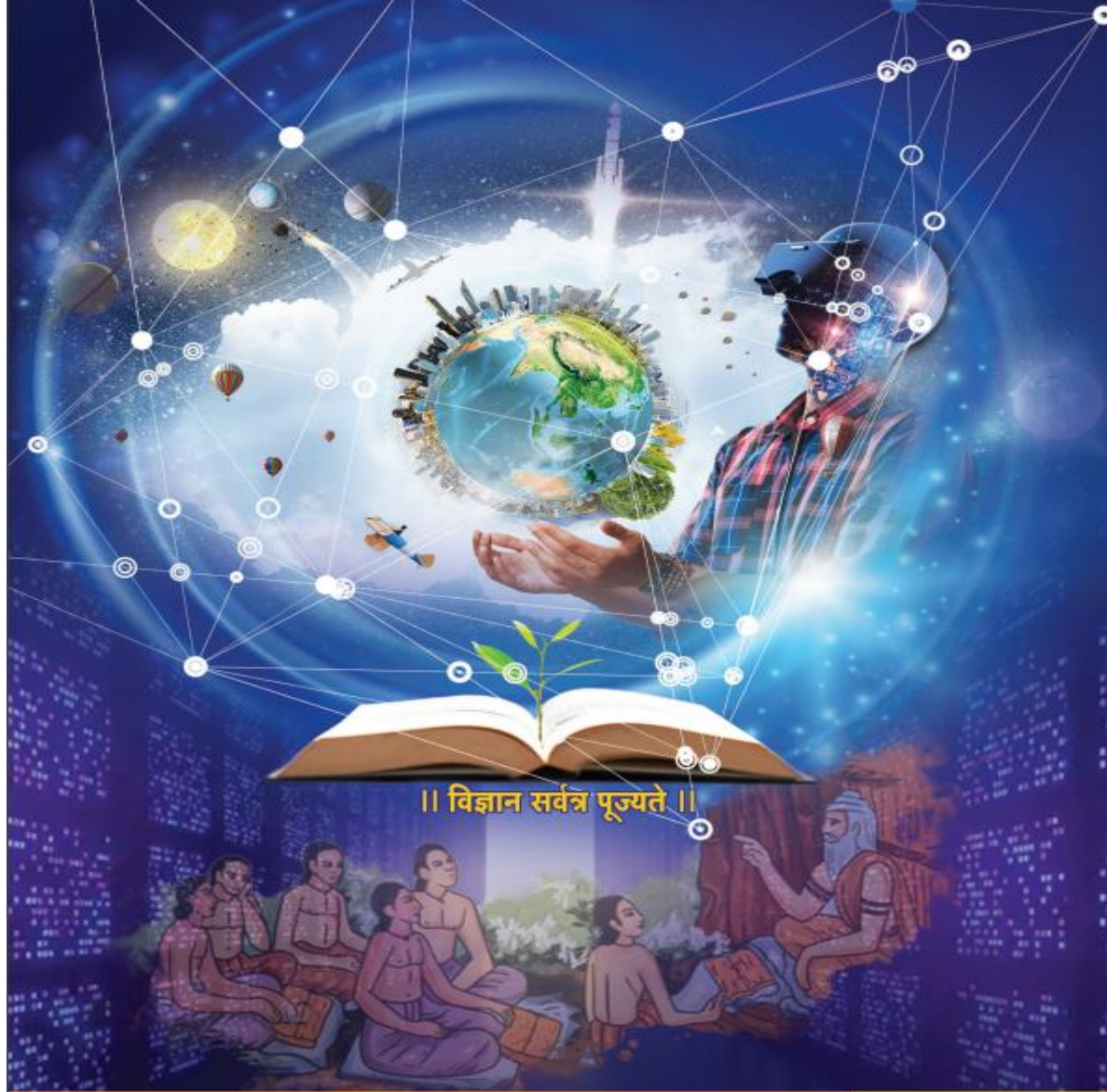
