
Subject: Azadi ka Amrit Mahotsav - Ek Bharat Shreshtha Bharat - Visit of Students to paired states - reg.

The undersigned is directed to say that it is proposed to organize 7- day visits of school and college students to their paired states as part of AKAM activity under Ek Bharat Shreshtha Bharat. As decided in a meeting of the Ministers of Education & MSDE, Culture and Youth Affairs and Sports held yesterday, the first of such visits is to be organized in June 2022, with 750 school students and 750 college students visiting their paired states. The undersigned is directed to say that during the celebrations of Azadi Ka Amrit Mahotsav (AKAM), this Ministry is organizing 7-day visits of school and college students to their paired states as part of AKAM activity under Ek Bharat Shreshtha Bharat. First of such visits is to be organized in 1st week of June 2022 with 750 school and 750 college students visiting their paired states. This event will be organised every month for two years with a target of 75 lakh students.

A meeting of the Steering Committee constituted for this purpose, was held on 19.5.2022, wherein it was decided that the M/o Railway would extend student concession to the students and teachers visiting paired states under student exchange program and also issue directions to Zonal Railway Divisions for block reservations of the students.



Sub: Withdrawal of concession in passenger fare for all categories of passengers except 4 categories of Divyangjan and 11 categories of patients till further advice in view of health advisory issued regarding COVID-19.

In view of health advisory issued regarding COVID-19 and to discourage passengers from undertaking non-essential travel, it has been decided, as a special case, that no concessional UTS and PRS Ticket for all categories of passengers except Students, 4 categories of Divyangjan and 11 categories of patients shall be issued.

2. The above shall be applicable for tickets booked on or after 20.03.2020 till further advice.
3. CRIS & IRCTC may make necessary changes in the software.
4. Necessary instructions shall be issued to the all concerned.
