This letter is in continuation to my DO letter No. 42-22/119/2022-AKAM dated 23rd May 2022 wherein details about "Har Ghar Tiranga" were conveyed.

2. On 2nd June 2022, Group of Ministers consisting of Hon'ble Minister of Textiles, Commerce and Industry, Consumer Affairs, Food & Public Distribution, Hon'ble Minister of Culture, Tourism & Development of North Eastern Region and Hon'ble Minister of Information & Broadcasting and Youth Affairs & Sports chaired a meeting to review preparedness of "Har Ghar Tiranga" and outlined following tasks to be undertaken to ensure successful implementation of the program.

- i. Panchayati Raj Department in all States/ UTs to be designated as Nodal entities for stocking and distribution of flags.
- ii. District Collectors to be suitably instructed to constantly monitor progress of implementation program.
- iii. Post offices, Panchayats, Common Service Centers to be utilized for distribution of flags.
- iv. Gram Sabhas may be used to ascertain demand of flags through Gram Pradhans.
