The National Museum of Natural History[NMNH] is pleased to invite you to an event on LiFE Mission (Lifestyle for Environment) for school students being conducted jointly by NMNH and GIZ India at the Ministry of Environment, Forest and Climate Change, Government of India, New Delhi premises, Indira Paryavaran Bhavan during the Second week of October, 2022. This two day event seeks to facilitate understanding as well as dialogue about various themes under this subject. The activities held herein would not only promote sustainable lifestyles but would also seek innovative ideas from the youth of this country.

Amidst various activities, the event shall put up an exhibition by school students on Mission LiFE, which is to be judged by a panel of experts. We seek creative entries from the school students for this competition as well as their participation in this event.

Rules for the Entrees:

- 1. The students participating can be from any class between 6-10.
- 2. The team can consist of a maximum of 4 students.
- 3. The exhibits will focuson any sector (Water, Waste, Energy, Food etc.) under Mission LiFE, with emphasis on any of the following three key aspects:
- Traditional sustainable lifestyle practices: What are the traditional practices that are sustainable, climate friendly, that could be adopted in today's life as well?
- b. Innovative ideas for Lifestyle for Environment: Do you have any new, exciting and innovative idea to share on Lifestyle for Environment? This could cover technology, behaviour, communication or any other field.
- c. My sustainable practices: Why don't you share what you practice to the world?
- 4. These exhibits can be in the form of: a. Model b. Display Boards c. Any other creative visualization that can be displayed as an exhibit
- 5. The team will be expected to set up the exhibit and explain the same to a panel of judges and visitors. (The exhibit itself is expected to be made in advance and not at the venue).
- 6. The size of the exhibit is to not exceed 3 feet×2 feet. A table and set of chairs will be provided to display the same.
- The materials used in the exhibit are to be eco-friendly and sustainable.
- As a preliminary selection round, the teams are required to send a concept note using the template attached in the email. The details to be noted are:
- a. Content: explaining the theme that they have chosen and a rough idea of the exhibit they plan to create

- b. Font: Arial 12, Word Limit: max 700 words, Word File Title: Exhibit Name, School Name.
- c. Deadline: 7th October, 2022
- Submit via Email to: nmnhdelhi2022@gmail.com & cr.magesh@gov.in with Subject Line as "Mission LiFE Exhibit: Exhibit Name and School Name"
