The portal for filling online application under various categories for approval for AY 2023-24 will be made live soon. Accordingly, Institutions / Institutions deemed to be University are directed to be ready will all the documents to be uploaded in the portal

Few requisite documents required to be uploaded on the portal are: -


1. NOC from affiliating University/Board/State Govt. for Increase in Intake/New Course/Programme.
2. Approved Building Plan
3. Occupancy Certificate/Completion Certificate etc.
4. Barrier Free Environment.
5. Fire Safety Certificate.
6. Digital Signature Certificate (DSC) for filling of online application and attestation of uploaded.
7. Requisite proof of Faculty qualification/Salary paid etc.

The above list is indicative and not exhaustive. The new applicants/stakeholder and all approved Technical Institutions are directed (In their own interest) once again to be ready with all the required documents before filling online application for the Approval w.r.t A/Y 2023-24.

Further, it has been observed that few Institutions are not disclosing the following information either in their website / campus:

- a) Display of information submitted to AICTE (including the accreditation status and Board of Governors) and Copies of AICTE approvals (LoA and EoA of subsequent years) obtained since inception of the Institution till date shall be placed on the Web site of the Institution
- b) Information about available Courses and approved Intake at the Entrance of the Institution
- c) Mandatory disclosures in the prime location of the Website (as a quick link) of the Institution
- d) Display board within the premises as well as on the Web site of the Institution Indicating the feedback facility of students and Faculty available in AICTE Web-Portal.

Accordingly, Institutions are directed to upload the above information in their respective website and disseminate information in their campus positively.
