



- 4. To look in to individual grievances of atrocity and of deprivation of safeguards issues based on review of Committee for SC and ST
- 5. To familiarize them with various financial schemes so that they may be benefitted from such schemes by way of workshop to create awareness on "Financial Scheme Awareness Programme" For Socio Economic Development of SC&ST.
- 6. To make provisions for providing information regarding various scholarship time and provide assistance to fill the form for different scholarship scheme Magnifort College College Tecnie Institute of Sales Scholarship portals through nodal officer.

- 7. To register as member of NSP 2.0 Portal and E-District Portal for providing scholarship support to the students belongs to SC/ST and appraise the house about the cases. -
- 8. To appraise the house about the cases received for any individual grievances of atrocity to SC and ST.
- To appraise the members about the recommendations contained in the Annual Report 2015-16 of National Commission for Scheduled Castes (NCSC), Govt. of India comprising of IX Chapters and 342 pages for Compliance Report point wise be prepared for onward submission to UGC through University annually.
