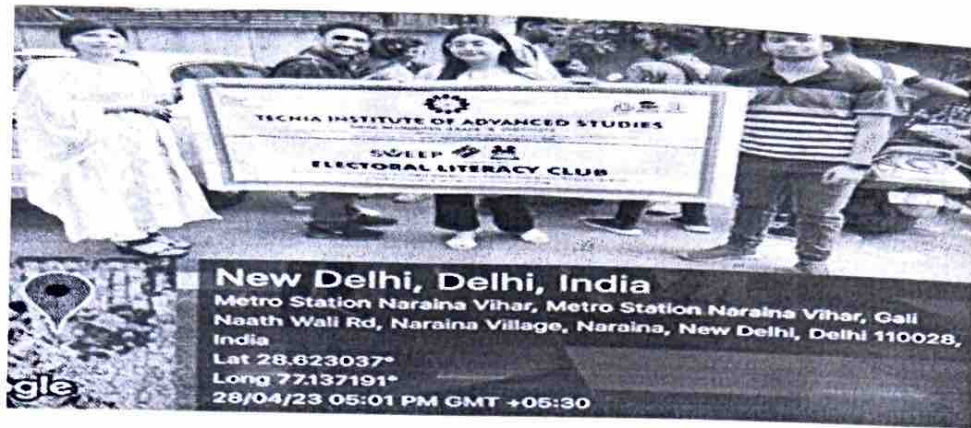

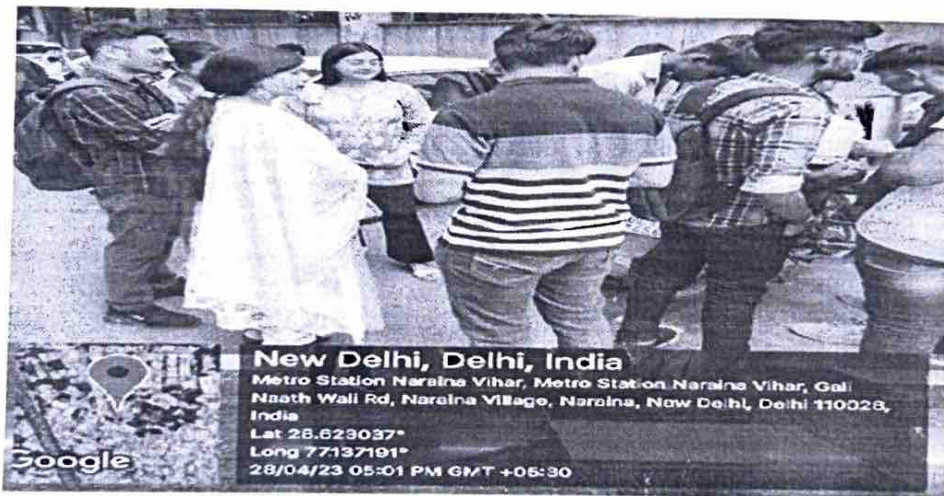

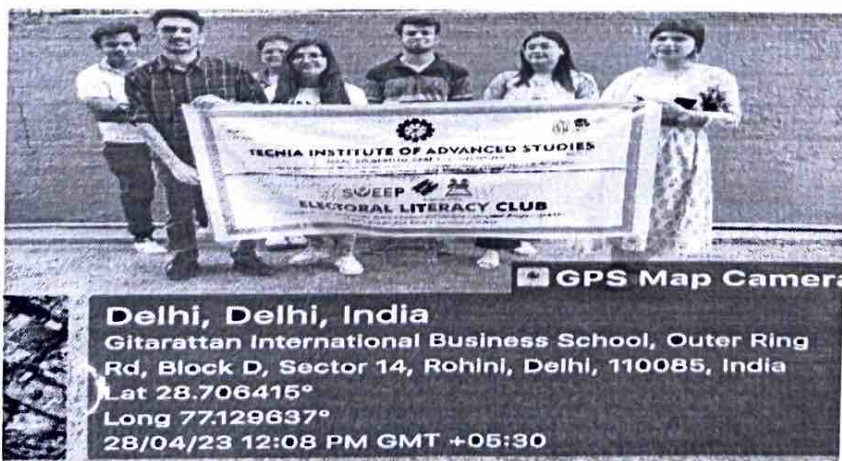

## REPORT

The Tecnia Institute of Advanced Studies (PSP, Institutional Area, Madhuban Chowk, Rohini), New Delhi-110085 organized a " Voter Registration Drive: Filling of Form -6 " on 28th April 2023. The event aimed to enhance students' knowledge about the registration process for voting. The event was organized by the Nodal Officer of the Electoral Literacy Club (ELC), Ms. Priyanka Singh, who is a faculty member in the BA(JMC) Department. The registration drive took place at two locations: Botanical Garden, near the nearby location and Botanical Garden Noida &, Pitampura, Rohini . These locations were chosen strategically to reach a wider audience and provide convenience to participants from different areas of the city.

During the event, several students actively contributed to educating people about how to fill Form 6, which is the application form for voter registration. They provided step-by-step guidance on the process, highlighting the required documents, information, and online platforms available for registration. The students used and interactive discussions to engage the participants and address their queries effectively.

The students demonstrated exceptional dedication and patience in explaining the registration process, ensuring that the participants understood the importance of accurate and complete information in Form 6. They emphasized the significance of providing valid identification documents, proof of address, and age verification to facilitate a smooth registration process.

Through their efforts, the students successfully educated the participants about the details required in each section of Form 6, such as personal details, family members' details, and previous electoral registration, if applicable. They also highlighted the importance of submitting the form within the specified timelines and the process for tracking the application status online.

The Registration Drive has been set in two different locations one is nearby "Botanical Garden" and another one is nearby "Pitampura". Many students who are 17+ who have not yet registered et registered themselves, as we give them Form 6 and also guide them about the ways to fill it students conveniently fill their Voter Registration Form .

The event concluded on a positive note, with participants expressing gratitude for the students' guidance and support. The registration drive served as an important step in creating

a culture of electoral participation and ensuring that every eligible individual becomes a registered voter. Ms. Priyanka Singh, the Nodal Officer and Assistant Professor of BA(JMC), expressed their appreciation for the students' active involvement and dedication in educating people about the registration process.
