Dear Sir/ Madam,

All Institutions are also requested to maintain the details of the student & faculty planting the trees viz; Full Name, Email Address, Number of Tree Planted, Name of the Tree and upload the same on AICTE portal (link will be shared soon).

As an incentive for carrying out plantation, students/ faculty/ staff members will be recognised as Pro Planet People. Students may be awarded 20 "AICTE Activity Points,"

as defined in chapter 6 of AICTE Internship Policy'. In addition, top 100 Institutes with maximum number of tree planted will be awarded with "Certificate of Appreciation" by AICTE.
