In reference to the above cited subject, undersigned on behalf of GGSIPU has attended the meeting held on 26/05/2023 at Jawahar Vyapar Bhawan under the Chairmanship of Dr. N. P Shukla, Member-Technical, CAQM alongwith representatives of various Institutions.

1. Undersigned has submitted the progress report of the plantation drive carrying out during the year 2022-23. GGSIPU had targeted total number of 48600 plants including shrubs/hedges and trees (31100 plants for East campus and 17500 for Dwarka Campus) for both campus (East and Dwarka). In East Campus, out of 31100 plants, PWD has planted 24800 during the 2022-23 and balance 6300 plants shall be kept in target of 2023-24. Dwarka Campus has achieved 100% i.e. target 17500 nos. plantation during mentioned period.

Therefore, University may target for plantation 12600 nos. plants (6300 nos. for East Campus and 6000nos. for Dwarka Campus) for the year 2023-24.

2. The Chairman has suggested that each University should take initiative for plantation through their affiliated colleges by planting minimum 1000 plants (Shrubs/hedge/trees) during the year 2023-24 and submit the action taken report to CAQM office after collecting from each affiliated colleges.

3. The Chairman also suggested that each University to initiate the plantation in their adopted villages. Here it is mentioned that GGSIPU has also adopted 5nos. villages named, Sureshera, Kharkari Nahar, Kharkhari Jatmal, Khera Dabur & Pandwaia Kalan in Najafgarh area. Earlier plantation drive was carried out by NSS/NCC wing of the GGSIPU in above villages. The competent authority is requested to issue the direction to the concerned wing for starting the plantation drive in above villages for 2023-24.

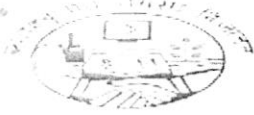
