IMPORTANT NOTICE: MANAGEMENT QUOTA SEATS : 2023-24

In continuation to earlier Notices/Communication of the University regarding Management Quota Admissions, it is once again reiterated that all the Self Financing Institutions are directed to follow instructions contained in Clause 8(2)(a)(vii) of the Delhi Professional Colleges or Institutions (Prohibition of Capitation Fee, Delegation of Admissions, Fixation of Non-Exploitative Fee and other Ensure Equity and Excellence), Rules, 2007 dated 14.06.2007 of Govt. of NCT of Delhi which states that; *the last date to fill up the Management Quota seats will be nine calendar days after the last date for regular admission in the University and the concerned course*".

Therefore, the last date mentioned in the Rules, 2007 as unanimously decided in the meeting with the Directors/Principals of the affiliated colleges shall be taken as last date of reporting of the admitted students in the concerned Institute for the respective programmes after the third round of counselling.

Further, the Spot counselling admissions for various programmes have no interconnection with the Management Quota Admissions. Thus it is for the candidate to take decision whether the candidates chooses to report in the allotted affiliated colleges after declaration of spot 1 result or chooses not to report and prefer to participate in Management Quota counselling.

It is also to inform you that there is second spot counselling for B.Tech. programme, which will be held after the management quota admissions in B.Tech. programme. Therefore, the spot counselling has no interconnection or any dependency on management quota admissions and so is vice-versa.


It has been desired by the Chairman, Admission Regulatory Committee that name of observer of the University (wherever appointed) appointed in affiliated college to observe Management Quota Admissions, shall be displayed alongwith observer phone number at the gate of institutions and at the entrance of counselling hall. The candidates whose name exists in merit list if prevented from entering the institution or counselling hall may contact observer. The Chairman has further desired that the candidates whose name exists in merit

list will not be prevented from attending counselling on the pretext of being late or for any other reasons by all affiliated colleges.

The candidates who have already taken admissions under Management Quota Seats in any Institute, shall not be eligible for taking admission under Management Quota Admission elsewhere in other affiliated colleges. The candidates shall also not be permitted to withdraw admissions from the Management Quota to participate in second spot counselling as the affiliated colleges are not permitted to conduct 03rd round of counselling for Management Quota.

It is also for information of candidates and affiliated colleges that wherever the Management Quota Admissions are taking place prior to commencement of 2nd Spot round counselling, the affiliated Institutions must allow the candidates to participate in the Management Quota counselling, even if the candidates has taken admission during centralized counselling with the undertaking that if successful in Management Quota admission, he/she will withdraw admissions taken in the centralized counselling before 2nd round of spot counselling. The list of such candidates who have taken admission in the Management Quota may be forwarded to the University to debar them for participating in second spot round of counselling.

The prospective candidates seeking admission in Management Quota are advised to visit the concerned Self Financing Institutions/Colleges website regularly for regular updates regarding Management quota admissions merit list, schedule of counselling. Any representation regarding having missed the schedule of counselling dates due to not being able to see the details, shall not be entertained by the Institute or the University. The candidates reporting late for Management Quota Admissions shall be permitted to attend the Management Quota counselling, however, the candidates will forfeit his claim on the seats which already gets filled, in the meanwhile during the counselling process and candidate reporting late shall only be entitled to the choices available in the management quota counselling at the time of his reporting.
