## Report:



She described what is patent and Criteria of Patentability, procedure of patent filing in India, and documents required for filing a patent. 
My understanding about the various types of intellectual property and their

importance has increased after attending the webinar




My understanding about the types of rights protected by Copyright has increased after attending the webinar






My understanding about the Criteria of Patentability has increased after attending Copy the webinar




My understanding about the documents required for filing the patent has increased locopy after attending the webinar




