

**Agenda 1: To read and confirm the minutes of the IQAC meeting dated 14.09.2023**

##### **NEP Progression through Seminars and Workshops**

- **Seminars:**  
Seminars have been conducted to spread awareness about the NEP's objectives, key features, and implementation strategies. Participants can engage in Q&A sessions to clarify doubts and discuss challenges related to NEP implementation.
- **Workshops:**

**Skill Development:** Workshops organized on enhancing the skills of both students and faculty in line with NEP's emphasis on vocational training and multidisciplinary education.

**Curriculum Development:** Workshops organize help faculty understand the new curriculum frameworks and pedagogical approaches recommended by NEP.

- **Capacity building and skill enhancement scheme:**  
It has been apprised by IQAC to members that the institute has designed the need based training program for the students of various program based on their aspirations and skill sets. He added that these programs are directed to assist the students plan their career path and upgrade their skills.
