INTRODUCTION

JOURNALISM

Journalism is the timely reporting of events at the local, provincial, national and international levels. Reporting involves the gathering of information through interviewing and research, the results of which are turned into a fair and balanced story for publication or for television or radio broadcast.

Journalism is not just

- Fact-finding
- Media analysis
- Opinion writing, or
- Commentary

Rather it is a discipline of gathering, writing and reporting news, and more broadly it includes the process of editing and presenting the news articles. Journalism applies to various media, including newspaper, magazines, radio, and television and since the end of 20th century, the Internet.

IMPORTANCE OF JOURNALISM

It is hard to think of a profession of greater public importance than journalism. What journalists publish and broadcast constitute the chief means whereby citizens inform themselves about public life in their societies, enabling them to play the role of active participants in democratic life. Journalism is particularly important as a provider of independent information about government, and therefore as one of the main checks on the power of the state. It also has the capability to monitor the activities of large, powerful institution- both profit and non profit- that affect the lives of the people. Indeed, in this complicated world, it is almost- impossible for people to keep informed about and engaged in public life without the presence of a well-trained and capable press. A well functioning democracy depends on good journalism. Markets cannot function well without reliable and timely information provided by a good journalist.

SIGNIFICANCE OF JOURNALISM

The central purpose of journalism is to provide citizens with accurate and reliable information they need to function in a free society. This encompasses myriad roles-helping define community, creating common language and common knowledge, identifying a community's goals, heroes and villains and pushing people beyond complacency. This purpose also involves other requirements, such as being entertaining, serving as watchdog and offering voice to the voiceless.

Here are six roles the modern journalist should serve:

- **The Ethical Role** - Yes, journalists get bashed about because of real and imagined lapses in ethics, but the challenge now is to raise the bar on professional ethics, and then provide ethical guidance to today's participatory audience. We should deal more swiftly and transparently with ethical errors within the profession, but we should also provide teaching tools on information ethics, what ethics means and why it's important, and how to spot compromised ethics.
- **The Guide/Filter Role** - Editors and reporters should assume some responsibility for providing their audiences with pointers to the best stuff on the web, be it the best-reported of the important news or the most interesting and entertaining articles and videos. In a command-and-control environment, we cared only about directing people to what we ourselves did. Now our role is to help audiences sift through the glut of information assaulting them daily by providing pointers. This

is the value-add role, and if done right it can help overcome the digital-age tendency for people to focus too narrowly on their own interests. If done well, it will bring more people to your site or publication.

- **The Understanding and Context Role** - Why should the best bloggers get to have all the fun? The best journalists should become the best bloggers. I know many really, really smart reporters and editors. These people should have blogs, and they should serve readers better by taking the news of the day and putting it in context, combing articles for the tidbits that need to be weaved together to make a bigger whole, and explaining what it all means.
- **The Conversation Leader Role** - Already, our news reports start a lot of conversations with our without our consent. The conversation-starter role should become explicit in our job descriptions. Once started, we should guide it. We should thank and encourage the good contributors, and depreciate the bad contributors We should highlight the smartest things people say. We should provide our own insights and supplemental knowledge to any conversation we find. We should be full participants, not just the lurking overlords of top-down media.
- **The Aggregator Role** - We should aggressively gather data related to the communities we serve. We should make sure that anything that is knowable about

a community we serve is findable through resources we provide. While in the Guide/Filter Role we might provide pointers, in the Aggregator Role, we make data available and let people find it for themselves. This is a role that serves the long tail of information, because we never know what other individuals might find useful, important or necessary.

- **The Straight News Role.** We cannot, even if we wanted to, and should not, cede our professional responsibilities to uncover news. We must know about everything important going on in the communities that we serve, and we should strive to be the first to tell our communities about the important news of the moment (note: no longer of the day, but of the moment). We must still be out in our communities gathering facts and organizing them in a way that is relevant and useful and then reporting the most important facts to our communities.

3. SOCIAL MEDIA

In the 1980s and '90s, according to “The History of Social Networking” on the technology news site Digital Trends, the internet’s growth enabled the introduction of online communication services such as CompuServe, America Online, and Prodigy. They introduced users to digital communication through email, bulletin board messaging, and real-time online chatting.

This gave rise to the earliest social media networks, beginning with the short-lived Six Degrees profile uploading service in 1997.

This service was followed in 2001 by Friendster. These rudimentary platforms attracted millions of users and enabled email address registration and basic online networking.

Weblogs, or blogs, another early form of digital social communication, began to gain popularity with the 1999 launch of the LiveJournal publishing site. This coincided with the launch of the Blogger publishing platform by the tech company Pyra Labs, which was purchased by Google in 2003.

In 2002, LinkedIn was founded as a networking site for career-minded professionals. By 2020, it had grown to more than 675 million users worldwide. It remains the social media site of choice for job seekers as well as human resources managers searching for qualified candidates.

Two other major forays into social media collapsed after a burst of initial success. In 2003, Myspace launched. By 2006, it was the most visited website on the planet, spurred by users' ability to share new music directly on their profile pages.

By 2008, it was eclipsed by Facebook. In 2011, Myspace was purchased by musician Justin Timberlake for \$35 million, but it has since become a social media afterthought.

Google's attempt to elbow its way into the social media landscape, Google+, launched in 2012. A rocky existence came to an end in 2018, after the private information of nearly 500,000 Google+ users was compromised by a data security breach.

The future of social media is limited only by the imagination of its stakeholders. The brief history of the industry has proven that the rapid change — advances in technology, more-strident financial demands, shifting cultural dynamics — will transform the current social media landscape.

ELECTRONIC MEDIA

Radio broadcasting was initiated in 1927 but became state responsibility only in 1930. In 1937 it was given the name All India Radio and since 1957 it has been called Akashvani. Limited duration of television programming began in 1959, and complete broadcasting followed in 1965. The Ministry of Information and Broadcasting owned and maintained the audio-visual apparatus including the television channel Doordarshan. The Government of India played a significant role in using the audio-visual media for increasing mass education in India's rural swathes. Projected television screens provided engaging education in India's villages by the 1990s.

Following the economic reforms satellite television channels from around the world—including BBC, CNN, CNBC, PTV, and other foreign television channels gained a foothold in the country. 47 million household with television sets emerged in 1993. Satellite and cable television soon gained a foothold. Doordarshan, in turn, initiated reforms and modernization. With 1,400 television stations as of 2009, the country ranks 4th in the list of countries by number of television broadcast stations.

On November 16th, 2006, the Government of India released the community radio policy which allowed agricultural centers, educational institutions and civil society organizations to apply for community based FM broadcasting license. Community Radio is allowed 100 Watt Effective Radiated Power (ERP) with a maximum tower height of 30 meters. The license is valid for five years and one organization can only get one license, which is non-transferable and to be used for community development purposes.

DIGITAL MEDIA

Digital media is any form of media that uses electronic devices for distribution. This form of media can be created, viewed, modified and distributed and via electronic devices.

Digital media is commonly used software, video games, videos, websites, social media, and online advertising. Digital media is a part of everyday culture, more and more business owners are starting to replace paper advertising with digital advertising.

Digital media has changed the way we educate, entertain, publish and interact with one another on a daily basis. And as a result of this influence, digital media pushes the business world out of the industrial age and into the information age. We are no longer writing things with paper and pen, but instead communicating through digital devices.

NEW MEDIA

New media is any media – from newspaper articles and blogs to music and podcasts – that are delivered digitally. From a website or email to mobile phones and streaming apps, any internet-related form of communication can be considered new media. New media is a catch-all term used for various kinds of electronic communications that are conceivable due to innovation in computer technology. In contrast to “old” media, which includes newspapers, magazines, books, television and other such non-interactive media, new media is comprised of websites, online video/audio streams, email, online social platforms, online communities, online forums, blogs, Internet telephony, Web advertisements, online education and much more. It is not very easy to draw the line between new and old media because the so-called old media has found new ways of representation in digital forms, leaving behind its conventional methods of representation. New media is considered to be the multimedia and digital form of communication happening via desktop and laptop computers, as well as phones, tablets and other devices. New media has introduced user interaction, rather than simply consuming media. New media can be customized to the users’ preferences and it can selectively link from one form of content to another.

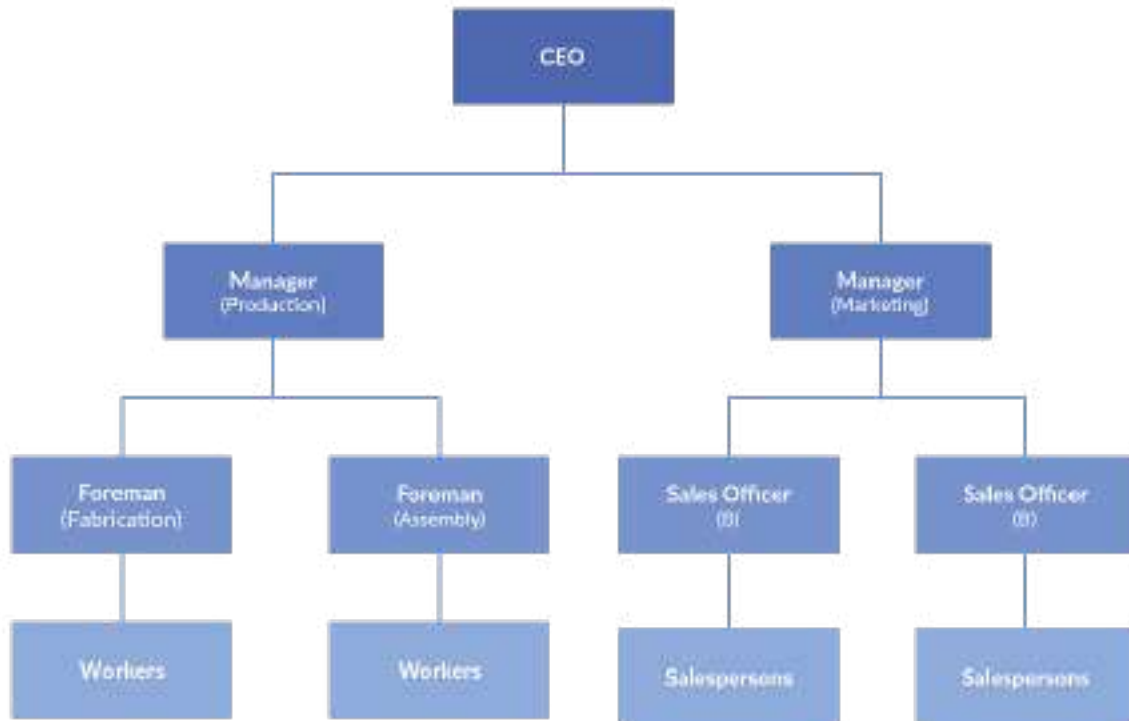

Dividing the firm into departments consisting of marketing, sales and operations is the act of using a bureaucratic organizational structure.

The second type is common among large companies with many business units. Called the divisional or multidivisional structure, a company that uses this method structures its

leadership team based on the products, projects or subsidiaries they operate. A good example of this structure is Johnson & Johnson. With thousands of products and lines of business, the company structures itself so each business unit operates as its own company with its own president.

Flatarchy, a newer structure, is the third type and is used among many start-ups. As the name alludes, it flattens the hierarchy and chain of command and gives its employees a lot of autonomy. Companies that use this type of structure have a high speed of implementation.

The fourth and final organizational structure is a matrix structure. It is also the most confusing and the least used. These structure matrixes employees across different superiors, divisions or departments. An employee working for a matrixes company, for example, may have duties in both sales and customer service. The traditional line structure is organized in such a way that a president or CEO (Chief Executive Officer) is at the top. Then there are the directors or VPs (Vice-Presidents) of specific areas, followed by managers, and so on, until the operational personnel. This structure can be seen below.

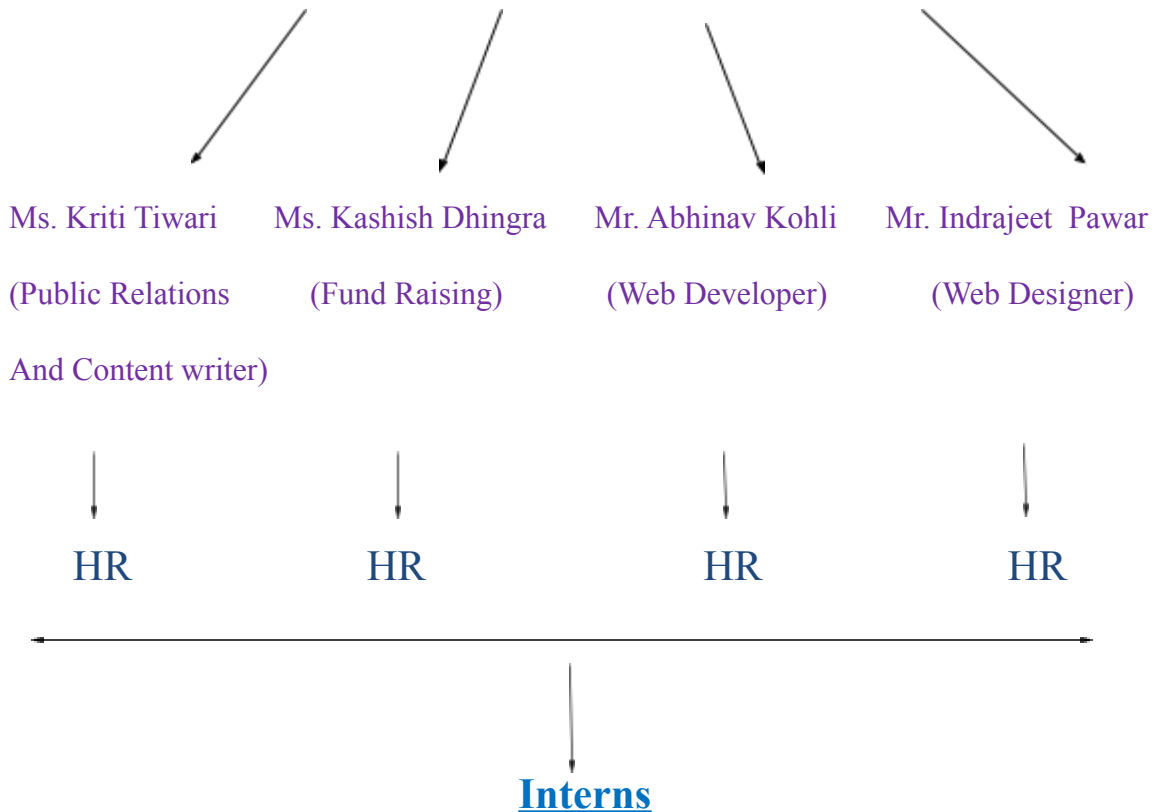


ORGANISATION STRUCTURE OF NON - GORVERNMENT ORGANISATION

REWRITING:

Rewriting is editing that involves writing something again. This rewriting is necessary to change the monotony of reading the same text again and again.

□ **REWRITING IS NOT HACKING:**

The upshot of this is that text identified as being hard to read should be improved by rewriting in the normal way (that is, using the techniques of good writing). Of course, shorter words and expressions should be sought, but the organization of the text should be reviewed to ensure it is clearly on one subject and the sentences flow easily.

□ DATA COLLECTION

Data collection is a term used to describe a process of preparing and collecting data - for example as part of a process improvement or similar project. The purpose of data collection is to obtain information to keep on record, to make decisions about important issues, to pass information on to others. Primarily, data is collected to provide information regarding a specific topic.

Data collection usually takes place early on in an improvement project, and is often formalized through a data collection plan which often contains the following activity.

- Pre collection activity – Agree goals, target data, definitions, methods
- Collection – data collection
- Present Findings – usually involves some form of sorting¹ analysis and/or presentation.

□ CONTENT CREATION

Content creation is the process of generating topic ideas that appeal to your buyer's Personality, creating written or visual content around those ideas, and making that

information accessible to your audience as a Poster, blog, video, info graphic, or other format.

□ ADDITIONAL SKILLS


