1.0 Preamble

3.0 Preamble

The Policy of CO-PO Attainment (Course Outcomes - Program Outcomes Attainment) is a framework used in academic institutions, to measure how well students have met the learning outcomes set for a particular course and how those outcomes align with broader program outcomes. COs (Course Outcomes) define what a student is expected to know or be able to do by the end of a specific course, while POs (Program Outcomes) are broader competencies students should have attained by the end of their academic program.

4.0 Objectives

- To evaluate the degree of effectiveness the students of a particular batch have acquired the knowledge, skills and attitude to become competent by completing various courses towards meeting set programme outcomes.
- To evaluate how well the course prepares students to meet the required program outcomes.

- To identify gaps or deviations between actual student achievements and the targeted Programme Outcomes.
- To take corrective measures after evaluating the deviation from required programme outcomes.
- To ensure that the effective teaching-learning process.

5.0 Scope:

This policy is applicable to all programmes offered (MBA, BBA, B.Com(H), BA(JMC), MCA, BCA) by the institution and covers all students, faculty members, and academic stakeholders involved in curriculum delivery and assessment.

6.0 Policy:

The CO-PO Attainment Policy outlines the process for defining, measuring, and evaluating the attainment of COs and POs, which serve as critical indicators of the program's effectiveness of teaching-learning process under by delivering the intended knowledge, skills and attitude through continuous monitoring and assessment towards making the students competent at the end of every academic programs MBA/BBA/BCA/BA(J&MC).

This policy involves:

1. Definition of Course Outcomes (COs) and Program Outcomes (POs):

COs (Course Outcomes): These are the specific and measurable intended learning to enhance the competency on the factors of knowledge, skill sets and attitude/behaviour expected from the students to demonstrate after completing each course.

POs (Program Outcomes): These are the specific and measurable intended learning to enhance the competency on the factors of knowledge, skill sets and attitude/behaviour expected from the students to demonstrate after completing each programme.

- 2. Mapping of Course Outcomes (COs) and Program Outcomes (POs): Aligning course outcomes assessing their contributions with overall program outcomes to ensure consistency and relevance.
- 3. Attainment Levels and Targets: Establishing performance thresholds for assessing the extent to which COs and POs are being achieved.
- 4. Continuous Improvement: Implementing corrective actions based on the deviation found between set and attained outcomes including adjustments to teaching strategies & resources.

7.0 Methods of CO and PO Attainment:

Direct Assessment (ET) – 80%:

External Assessment (EA):

Internal Exam (INT)

Assignment (A)

Group Discussion (GD)

Class Presentation (CP)

Indirect Assessment (IA) – 20%:

Feedback of stakeholder (F)

Formula used for Calculation of Attainment

Attainment = 0.80*(0.75*EA + 0.25*INT/A/GD/CP) + 0.20*(f)

Internal Exam (INT) include exams, quizzes, assignments, projects, and laboratory work where the learning outcomes are evaluated based on student performance.

Indirect Assessment: This could involve surveys, interviews, or feedback from students and faculty regarding their perception of whether the outcomes are being achieved.

CO-IND= 0.20* (f/es)

CO = A + B = (CO-D) + (CO-IND) = 0.80* (0.75*EA + 0.25*INT/A/GD/CP) + 0.20* (f/es)

8.0 Rubrics of Attainment:

The attainments of COs and POs has been rated on a scale 1 to 3:

- 1 Slight (Low): The outcome is partially achieved.
- 2 Moderate(Medium): The outcome is moderately achieved.
- 3 Substantial (High): The outcome is fully achieved.

This helps in measuring not just whether the students achieved the outcome, but how well they did so.

9.0 Continuous Improvement:

A key element of any CO-PO attainment policy is continuous improvement to meet objectives by finding deviation and taking appropriate action to arrest deviation on continuous basis.
