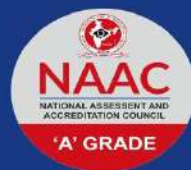

1.0 Preamble

4.0 Preamble

Tecnia Institute of Advanced Studies (TIAS) is committed to sustainable financial growth through diversified funding sources to support academic excellence, research, infrastructure, and institutional development. This policy outlines the framework for mobilizing, managing, and utilizing funds in a transparent and accountable manner.

5.0 Purpose

The Resource Mobilization Policy of Tecnia Institute of Advanced Studies (TIAS) aims to develop a transparent and efficient financial management system that supports institutional development, academic excellence, and sustainable growth.

6.0 Objectives

- To ensure transparency and accountability in resource mobilization.
- To establish systems for efficient coordination and monitoring of financial resources.
- To enable optimal utilization of funds in alignment with the institution's vision and mission.
- To promote self-reliance through diversified funding sources.

7.0 Coverage Areas

The policy encompasses mobilization and utilization strategies across:

- Academic and administrative infrastructure: buildings, labs, classrooms.
- Technology and ICT resources: Computers, Software, Projectors, Internet facilities.
- Scientific and laboratory equipment.
- Library resources: books, journals, e-resources.
- Student and faculty development programs.
- Sports and extracurricular facilities.

8.0 Sources of Funding

TIAS mobilizes resources through multiple channels:

- Student tuition and other institutional fees.
- Grants from Government agencies/ Non- Government agencies and others.
- Research grants and project funding
- Income from consultancy services and industry collaboration.
- Corporate sponsorships and CSR contributions.
- Alumni contributions and endowment funds.
- Renting institutional facilities for events, examinations, or training by external agencies.
- Workshops, FDPs, and certificate programs conducted on a self-financed basis.

- Savings and interest on fixed deposits.

9.0 Utilization and Monitoring

- Funds are allocated for teaching-learning enhancement, infrastructure development, faculty training, and student-centric activities.
- Annual budgets are prepared and approved by the management.
- Utilization of grants follows the guidelines of the funding agencies.
- Internal and external audits ensure accountability.
- Committees such as the Finance Committee, Planning Committee, and Purchase Committee oversee fund utilization.

10.0 Financial Audit and Compliance

- All financial statements and fund utilization reports are audited annually.
- Utilization certificates and audited reports are submitted to the concerned authorities.
- Financial compliance is maintained as per statutory requirements.
